### Nearly One-third Of US Parents Don't Know What To Expect Of Infants

Almost one-third of U.S. parents have a surprisingly low-level knowledge of typical infant development and unrealistic expectations for their child's physical, social and emotional growth, according research from the University of Rochester. The new findings, which suggest that such false parenting assumptions can not only impair parent-child interactions, but also rob kids of much-needed cognitive stimulation

Moms and dads often misinterpret behaviors -- some parents expect too much of babies too soon and grow frustrated; others underestimate their child's abilities, preventing them from learning on their own.

## California Family Economic Self-Sufficiency Standard by County

The <u>Insight Center for Community Economic Development</u> just released the 2008 California Family Economic Self-Sufficiency Standard, and the report "How Much is Enough in Your County? The 2008 California Family Self-Sufficiency Standard." The new Self-Sufficiency Standard shows that the cost of basic goods in every county has risen significantly over the past five years.

The Family Economic Self- Sufficiency Standard (Self-Sufficiency Standard) measures how much income is needed for a family of a certain composition living in a particular county to adequately meet its minimal basic needs. It is based on the costs families face on a daily basis - housing, food, child care, out-of-pocket medical expenses,

transportation, and other necessary spending - and provides a complete picture of what it takes for families to make ends meet. In contrast, the Federal Poverty Level (FPL), which was developed in the early 1960's and is used to determine income eligibility for many public programs, is based on the outdated assumption that food represents onethird of a family's budget. The FPL also fails to take into account housing and transportation costs, geography, and, most importantly, child care costs, which are increasingly more expensive. For a family of four-whether in a high cost market like San Francisco, CA or a more affordable market like Baton Rouge, LA-the poverty level is \$21,200 in annual household earnings.

#### TRUSTLINE REGULATIONS OUT FOR PUBLIC COMMENT



The Superintendent of Public Instruction released the proposed TrustLine regulations for public comment. These regulations will address one issue: TrustLine registration for

applicable license- exempt providers of subsidized child care and development services.

The proposed regulations add two new sections (18224.6 and 18227) to the Alternative Payment program regulations (Division 1, Chapter 19, Subchapter 10) to clearly identify who qualifies as an eligible provider and what happens when a license- exempt provider becomes ineligible to provide child care and development services. The majority of section 18227 comes from the existing section 18074.2(a). The content of that section is modified to reflect the requirement for the license-exempt provider, who is not the child's grandparent, aunt, or uncle, to be TrustLine registered to be considered an eligible provider for rendering subsidized child care and development services.

### What Does Economics Tell Us About Early Childhood Policy?

An increasing chorus of Fortune 500 CEOs, Federal Reserve Bank analysts, Nobel Prizewinning economists, and other business and economic leaders have led the call to increase public "investments" in early childhood. This call is driven by research findings that increasingly emphasize the importance of laying a strong foundation in early childhood and that show that a range of early interventions can successfully put children on the path toward positive development, preventing poor outcomes in adulthood. These findings-along with increasing recognition in the public-health and social- service sectors that providing program services in early childhood has benefits over treatment later in life-have contributed to the evolution of economists' support for early childhood investments.

To help decisionmakers in the public and private sectors, service providers, and the public more generally, RAND researchers drew on their decades-long expertise in applying economics to early childhood issues to demonstrate how two economic concepts-human capital theory and monetary payoffs-contribute to a unifying framework that provides evidence-based guidance for early childhood policy. These concepts are summarized in this research brief.

### Preschool enrollment up dramatically

The most recent federal statistics show that in 10 years preschool enrollment in the United States increased 63 percent to more than 1 million children.

The increase, which took place between 1995 and 2005, far outpaced the 10 percent hike in regular public school enrollment, USA Today reported Monday.

Education experts attribute the rise to more mothers Making a world of difference in the workforce as well as states stepping up to finance preschool programs.

California's structural budget deficit persists. Slower rates of economic growth, softening state revenues and increased costs have widened California's budget gap. In January, the projected deficit for 2008-09 was \$14.5 billion. Left unaddressed, the projected gap would grow to \$24.3 billion based on updated revenue projections, revised caseload estimates and higher costs. The single largest factor contributing to the increase in the projected budget gap is a \$6.0 billion decrease in estimated General Fund revenues. Other factors include increased program costs, higher estimates of growth and costs of living adjustments, and erosion of savings due to delays in the adoption of reduction proposals. A Special Session of the Legislature made a down payment to address the budget deficit; now, the remaining budget gap is \$17.2 billion.
